- ▶ An all-electric property.

### DIRECT INSTALL PROGRAM

Provided at a cost of \$20 per residential unit, the Direct Install Program includes the following:

- ▶ Screw-based LED light bulbs to replace incandescent bulbs.
- ▶ Efficient-flow kitchen faucet aerators.
- ▶ Efficient-flow bathroom faucet aerators.
- ▶ Efficient-flow showerheads.
- ▶ Advanced power strips for TVs or computers.
